### **COMPETITION TERMS AND CONDITIONS**

## I. Preliminary Provisions

1.1 The subject of these competition terms and conditions (hereinafter referred to as "Terms and Conditions") is to set binding rules for the competition organized by the Organizer.

1.2 The relationship between the Organizer and the Competitors is subjected to these Competition Terms and Conditions (hereinafter referred to as "Terms and Conditions").

# II. Definition of Terms

2.1 The Organizer is Mezinárodní filmový festival Praha - FEBIOFEST s.r.o., with its registered office at Prague 1, Růžová 951/13, Reg. No.: 26721546, registered at the Commercial Register maintained by the Municipal Court in Prague, Section C, Insert 89545.

2.2 The Competitor is a person that is duly registered at the Organizer's server in accordance with the General Terms and Conditions.

2.3 The Competitor is a User participating in the Competition organized by the Organizer.

2.4 The Finalist of the Competition is a User whose film is selected by a jury appointed by the Organizer for the finals.

2.5. The Winner of the Competition is the User whose film is selected by the jury appointed by the Organizer.

2.6 The Competition is considered launched by the Competition Announcement published by the Organizer at <u>www.febiofest.cz/en/you-are-the-filmmaker</u> and operates according to the Competition Terms and Conditions.

2.7 The start of the Competition is the day set as the start of the Competition on the day of the Competition Announcement.

2.8 The end of the Competition is outlined in the Competition Announcement.

# III. General Rules

3.1 Any and all registered Users agreeing to these Competition Terms and Conditions and General Terms and Conditions may participate in the Competition with the exception of the Organizer's employees, partners, and family members.

3.2 Only a natural person aged 18 or over who permanently lives in the Czech Republic, or a person at least 13 years of age who is represented by a legal guardian during the competition and during the awarding of the Prize may enter the Competition.

3.3 A person not agreeing to these Terms and Conditions cannot enter the Competition.

3.4 The Competition is considered launched by the Announcement on the Organizer's website.

3.5 The Competitor enters the Competition by saving their film to <u>www.febiofest.cz/en/you-are-the-filmmaker</u> and by agreeing to the Terms and Conditions. He thus becomes an active Competitor. The film can have an older production date, but it shall not have been previously released nor entered any competition whatsoever in the past.

3.6 The Competitor will receive the Prize via bank transfer within 30 days to the bank account provided upon signing the Contract. The Organizer will fulfil his obligation to the Competitor with the bank transfer.

3.7 A guarantee of winning is not provided. From the moment the Prize is handed over, the Organizer is not liable for a faulty or damaged Prize item. The Competitor is aware of this.

3.8 The Prize cannot be claimed in court.

3.9 Competitors whose videos fulfil the following conditions may enter the competition:

- uploaded on <u>www.febiofest.cz/en/you-are-the-filmmaker</u> by 20 February 2019 at the latest; while uploading the film, the Competitor must agree to the Terms and Conditions and provide his contact information.
- the topic is "Fake news, hoax"
- Competitors: anyone 13 years old and up with a permanent address in the Czech Republic
- A school team must be registered by a responsible teacher
- the length of the film: 1 3 minutes
- resolution: HD 1080p
- format: wmv, mpeg, mov, avi, mp4
- number of shots per second must be 24 or 25 fps
- films can be shot with any type of device

## **IV. Competition Categories and Prizes**

4.1 Competitors are allowed to sign up for only one of the following categories:

- "INDIVIDUAL" category A person 13 years and up with a permanent address in the Czech Republic
- "SCHOOL TEAM" category (A team is a minimum of 2 people or a maximum of 3 people from the same school; each member of the team must be of the minimum required age of 13 years and have a permanent address in the Czech Republic. Teams must be entered in the competition by a responsible teacher, who is not among the competitors). Primary, secondary, and schools of higher education can compete in this category

4.2 There will be three awards for each competing film category:

"INDIVIDUAL" category:

1st place: 20 000 CZK, Samsung Galaxy A7 mobile phone and voucher to the O2 library worth CZK 1,000

2nd place: 10 000 CZK, Samsung Galaxy Tab A 10.1 LTE 32 GB tablet and voucher to the O2 library worth CZK 500

3rd place: 5 000 CZK and voucher for a year of O2 TV worth 3,000 CZK

#### "SCHOOL TEAM" category:

1st place: Financial donation of 30 000 CZK to the school you attend. The donation is intended for educational activities in the field of internet and media literacy. Each member of the competing team will also receive a ticket to the festival.

2nd place: Financial donation of 20 000 CZK to the school you attend. The donation is intended for educational activities in the field of internet and media literacy. Each member of the competing team will also receive a ticket to the festival.

3rd place: Financial donation of 10 000 CZK to the school you attend. The donation is intended for educational activities in the field of internet and media literacy. Each member of the competing team will also receive a ticket to the festival.

# V. Rights and Obligations of the Competitor

5.1 The Competitor confirms that s/he enters the Competition voluntarily.

5.2 The Competitor confirms that the film produced for entering the competition has never been released nor has participated in any other competitions.

5.3 The Competitor is obliged to provide complete and accurate contact information which is important for receiving and sending/awarding the Prize.

5.4 The Competitor who becomes a Finalist or the Winner is obliged to respond to the Organizer's message within 3 business days. Ignoring the message voids the claim of participating in the finals as well as the possibility of winning.

5.5 Communication from the Organizer will be carried out either by telephone or by electronic mail, i.e., via e-mail.

5.6 If the Winner does not respond within 3 business days, the Prize will be forfeited to the Organizer. The Organizer reserves the right to nominate a substitute Winner who will thus be substituted for the original Winner who has not responded to the message.

5.7 The Competitor shall not share his user account with another person and shall keep his login details confidential.

5.8 The Competitor shall behave in accordance with valid legislation of the Czech Republic and his actions shall not cause any damage whatsoever to the Organizer nor to other Competitors.

5.9 The Competitor shall possess all copyrights to the film, both visual and audio.

5.10 By uploading the video on <u>www.febiofest.cz/en/you-are-the-filmmaker</u>, the Competitor grants his consent to the Organizer for further use of the video and distribution within the Mezinárodní filmový festival Praha - FEBIOFEST s.r.o event and through all possible channels (television, internet, cinema,...). The granted consent is limited by neither time nor territory.

5.11 All submitted films may be further shared by the O2. The film creators agree to the condition that they may not demand additional compensation from the O2 for the granting of such consent.

# VI. Rights and Obligations of the Organizer

6.1 The Organizer shall inform the Winner of his winning by 15 March 2019 via the email address which the Winner provided during User registration on one of the Organizer's servers.

6.2 The Organizer fulfils his obligation to award the Prize to the Winner either in person at the Organizer's premises, or by sending the Prize to the address provided by the Winner, or by personal collection by the Winner.

6.3 The Organizer reserves the right to terminate the Competition, change the Competition or cancel it without providing a reason in the event of unexpected events or events of force majeure. In this situation, the Competitor is not entitled to any compensation or settlement whatsoever.

6.4 The Organizer is in no way liable for possible damages caused by system failure or by the failure of programme equipment which are not caused by intentional acts on the part of the Organizer. In this situation, the Organizer reserves the right to terminate the Competition, change the Competition, or cancel it without providing a reason. In such a case, the Competitor is not entitled to any compensation or settlement whatsoever.

# **VII.** Personal Information

7.1 All data provided by the Competitor are considered as his private information and are protected by Bill 101/2000 Col. on personal data protection. The Competitor confirms that he understands that providing his details is voluntary and that he has the right to access them.

7.2 The Organizer shall not provide the Competitor's personal details to any other third party except third parties related to Mezinárodní filmový festival Praha - FEBIOFEST s.r.o. (i.e., such organizations or persons which co-organize the aforementioned Competition together with Mezinárodní filmový festival Praha - FEBIOFEST s.r.o.). The Competitor agrees that the details of the Winners, i.e., name, surname, and city of the Winner, may be published on the Organizer's website and shared by the Organizer on the internet. These details can be accompanied by an audio-visual recording.

7.3 The Competitor hereby agrees to a subscription of the FEBIOFEST NEWSLETTER as well as to receiving information on the Organizer's upcoming events. In such a case, this information will be sent solely from the Organizer's system.

## **VIII. Final Provisions**

8.1 These Competition Terms and Conditions are created in accordance with applicable laws and other legislation of the Czech Republic. The Competitor confirms by his registration and uploading of his video at <u>www.febiofest.cz/en/you-are-the-filmmaker</u> that he has been made aware of these terms in a verifiable manner, and is committed to adhering to them.

8.2 These Competition Terms and Conditions are valid from 4 January 2018.
